To have your dog judged by two different judges at these events, you will need to be present for judging in both the morning and the afternoon.

Both Farm Dog and Fetch judging will begin at 8:00 AM with a lunch break at approximately 12:00 PM.

Both Farm Dog and Fetch judging will begin again at approximately 1:00 PM until 5:00 PM.

A one-hour lunch break will be observed at approximately 12:00 – 1:00 PM.

Day-of entries ONLY accepted by printing attached entry forms and bringing them to event site on 10/21/24. Accepted payment for day-of entries – credit or cash only. No checks accepted. No entries accepted by mail.

We recommend you pre-enter. Limit of 20 dogs judged per event in morning and afternoon.

These events open to Samoyeds only until September 15, 2024. At that date, if entry times remain available, entries open to all breeds.

WAIT LIST INFORMATION

The Samoyed Club of America is not offering a wait list to fill openings created by withdrawn entries.

DOGS ELIGIBLE TO ENTER FETCH TRIAL

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Females in season may not enter.

DOGS ELIGIBLE TO ENTER FARM DOG TRIAL

The trial is open to all dogs NINE (9) months of age or older individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or dogs enrolled in the AKC Canine Partners Program. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number)

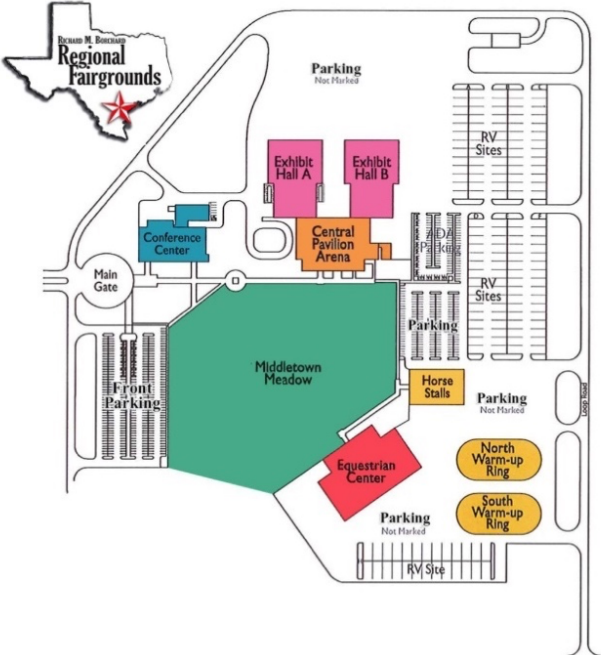
Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

WHAT TO DO WHEN YOU ARRIVE

If you pre-entered, you will have been given a time slot for your testing that will be emailed to you prior to arrival.

- * Check in at front table
- * Please bring a chair, a crate, water, and an optional canopy.
- * At briefing, you will be given further instructions.

There will be a secretary’s table for check-ins and information. **Exhibitors MUST check-in**

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering these events, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes, and Harnesses. Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane.

Livestock Death/Injury: Exhibitors are responsible to pay for any livestock death caused by their dog(s). Replacement value for sheep/goats is \$250, chickens/ducks \$55, In case of any injury to stock caused by the dog, the exhibitor assumes total responsibility for any damage and will pay the full veterinarian bill or the cost of replacement.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

- Directions from the Omni Hotel: 21.2 miles
Take I-37 N; follow I-37 N and I-69E S/US-77 S to TX-44 W in Robstown. Take the TX-44 E exit from I-69E S/US-77 S. Take Terry Shamsie Blvd. to your destination.
- Directions from San Antonio: 134 miles; 1 hr. 55 min.
Follow I-37 S for 127 miles. Merge onto US-77 S via EXIT 14 toward KINGSVILLE / BROWNSVILLE. Take the exit toward TX-44 EAST / ALICE. Turn LEFT under the underpass. Stay straight and it becomes Terry Shamsie Blvd.
- Directions from Houston: 210 miles; 3 hr. 13 min.
Follow US-59 S for 125 miles. Take the US-77 S ramp to Refugio/Corpus Christi for 71 miles. Merge onto I-37 S/I-69 E/US-77 S; go 2 miles. AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
